Job Description

Responsible for coordination and implementation of residential/hospital treatment program for high-risk children. Provides direct supervision to preadolescents and/or adolescents with specific issues and behavior disorders. Actively participates in the treatment of clients in relationship to his/her milieu. Collaborates with the treatment team during treatment planning meetings. Provides customer service to meet internal and external customer needs. Develops, organizes and implements structured groups and activities for the clients enrolled in the program. Varied schedules, evenings, weekends, nights.

Specific Duties

- Responsible for coordination and implementation of residential/hospital treatment program (10%)
- Provides direct supervision of preadolescent and/or adolescent with specific issues and behavioral disorders (40%)
- Completes all documentation requirements in a timely manner
- Responsible to communicate therapeutically and effectively with clients, families and members of the treatment team (5%)
- Responsible to assist with providing a therapeutic environment for clients (5%)
- Performs instructional and supportive tasks outside the classroom to assist the education staff (5%)
- Attends all mandatory training and meets the yearly requirements of 40 hours of training as set forth by Licensing. (5%)
- Develops, organizes and implements scheduled events for residential milieu (residential only) (5%)
